

RESOLUTION NO. 04 Series of 2023

ENJOINING THE LOCAL GOVERNMENT UNITS (LGUs) TO SUPPORT THE COMPILATION OF THE PROVINCIAL PRODUCT ACCOUNTS (PPA) OF THE PROVINCES OF BARMM

WHEREAS, Section 5-E, BEDC Resolution No. 01 series of 2020 states that the Regional Statistics Committee as part of its functions and responsibilities shall implement statistical coordination mechanisms being prescribed by the Philippine Statistics Authority (PSA) such as statistical standard classification systems, statistical calendar and statistical survey review and clearance system in the BARMM;

WHEREAS, pursuant to the Philippine Statistical Act of 2013, the Philippine Statistics Authority (PSA) is the central statistical authority of the Philippine government in primary data collection and the development of integrated social and economic statistics including the national accounts;

WHEREAS, the PSA regularly compiles the Quarterly and Annual National Accounts, the Gross Regional Domestic Product (GRDP), the Gross Regional Domestic Expenditure (GRDE), and other relevant Macroeconomic Indicators;

WHEREAS, in order to better understand the performance of the economy and to ensure more effective planning for economic and social development, the data should be characterized further at the sub-regional level;

WHEREAS, Provincial Product Accounts (PPA) aims to present a comprehensive picture of the provincial economy by providing a more appropriate measure and assessment of the economic performance and progress and development of all provinces;

WHEREAS, the RSCom provides direction and guidance in the regional/local statistical development activities and serves as the policy-making body on statistical matters and venue for discussion and resolution of statistical issues at the local level;

WHEREAS, the Philippine Statistics Authority (PSA) shall serve as the lead agency in the conduct of the PPA:


WHEREAS, the Provincial Local Government Units (PLGUs) shall provide and extend support to the PSA in the compilation of the provincial product account;

WHEREAS, the Ministry of Interior and Local Government (MILG) is mandated to exercise general supervision over the constituent local government units of the Bangsamoro Government, and ensure public safety and disaster preparedness, local autonomy, decentralization, and community empowerment;

WHEREAS, through the PSA, in coordination with the Ministry of the Interior and Local Government (MILG), the conduct of PPA will be actively participated by Local Government Units in BARMM;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, all Local Government Units (LGUs) are enjoined to fully support the implementation of Provincial Product Accounts (PPA) by providing data requirements needed for PPA Compilation;
