RESOLUTION NO. 13 Series of 2023

ENJOINING ALL CITY AND MUNICIPAL LOCAL GOVERNMENT UNITS (LGUS) AND SPECIAL GEOGRAPHICAL AREA (SGA) OF BARMM THROUGH THE MINISTRY OF INTERIOR AND LOCAL GOVERNMENT (MILG), THE RSCOM MEMBERS, OTHER MINISTRIES, LINE AGENCIES, AND OFFICES OF BARMM TO SUPPORT THE 2023 FAMILY INCOME AND EXPENDITURE SURVEY (FIES)

WHEREAS, the 2023 FIES enumeration will be conducted twice: the first visit will be on July 2023 with the first semester (January to June) of 2023 as the reference period, and the second visit will be on January 2024 with the second semester (July to December) of 2023 as reference period;

WHEREAS, one of the major household surveys conducted every three years by the Philippine Statistics Authority (PSA) is the Family Income and Expenditure Survey (FIES);

WHEREAS, the FIES aims to:

- Gather data on family income and family living expenditure and related information affecting income and expenditure levels and patterns in the country;
- Determine the sources of income distribution, levels of living and spending patterns, and the degree of inequality among families;
- Provide benchmark information to update weights in the estimations of the Consumer Price Index (CPI); and
- Provide inputs in the estimation of the country's poverty threshold and incidence.

WHEREAS the FIES is important for the;

- Estimation of the household account in the System of National Accounts and balances;
- Measurement of the Human Development Index (HDI);
- Measurement of poverty; and
- Measurement of the levels of living conditions of different sections of the population and disparities in levels of living across geographical regions and socio-economic groups and for inter-temporal comparisons of these levels of disparities.

WHEREAS, the FIES results are valuable inputs in development planning, policy formulation, and monitoring development activities;

WHEREAS, the Ministry of Interior and Local Government (MILG) is mandated to exercise general supervision over the constituent local government units of the Bangsamoro Government, and ensure public safety and disaster preparedness, local autonomy, decentralization, and community empowerment;

WHEREAS, through the PSA, in coordination with the MILG, the conduct of the 2023 FIES will be supported by LGUs in BARMM;

WHEREAS, the BARMM RSCom provides direction and guidance in the regional/local statistical development activities and serves as the policy-making body on statistical matters and venue for discussion and resolution of statistical issues at the local level;

WHEREAS, the RSCom recognizes the importance of 2023 FIES in statistical development in BARMM and in the whole country as well:
