**INVITATION TO BID FOR THE PROCUREMENT OF TRAINING AND ENUMERATION SUPPLIES FOR  
THE 2024 CENSUS OF POPULATION AND COMMUNITY-BASED MONITORING SYSTEM  
IMPLEMENTATION**

1. The **Philippine Statistics Authority – Regional Statistical Services Office BARMM (PSA-BARMM)** through the General Appropriations Act of 2024, intends to apply the sum of **TWO MILLION NINE HUNDRED FORTY THOUSAND PESOS (PhP2,940,000.00) ONLY** being the **Approved Budget for the Contract (ABC)** to payments under the contract for acquisition of 2024 POPCEN-CBMS Project. Bids received in excess of the ABC shall automatically be rejected at bid opening.

2. The **PSA-BARMM** now invites bids for the procurement of Training and Enumeration Supplies for the 2024 Census of Population and Community-Based Monitoring System Implementation. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from PSA- BARMM and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
5. A complete set of Bidding Documents may be acquired by interested Bidders from **June 4, 2024** and onwards prior to the bid opening from the address below and upon payment of the

applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount specified in Lot No. 1. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **PSA-BARMM** will hold a Pre-bid Conference at 2:00pm on **June 11, 2024** at the PSA-BARMM, Mega Supreme Holdings Corp. Bldg., ND Avenue corner Doña Theresa, Poblacion III, Cotabato City.
7. Bids must be duly received by the RBAC Secretariat at the address below on or before 12:00 nn of **June 24, 2024**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated **in ITB Clause 18**. Bid opening shall be on 1:30 P.M. of **June 24, 2024** at the Conference Room of the PSA - BARMM. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. At the most two representatives from each prospective bidder shall be allowed to attend the pre-bid conference. Additionally, only those who have purchased the bidding documents can ask questions.  
Furthermore, interested bidders may bring pictures or brochures during the pre-bid conference (Optional).
9. The **PSA-BARMM** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
